Milanuk made a motion to waive the reading of the meeting notice. Moffat seconded the motion. Roll call vote: Yea: All present. Motion carried.

INTRODUCTION OF GUESTS

Kendra Strommen

Executive Session

An Executive Session was called at 8:32 a.m. by Moffat to discuss a FERC Settlement matter and the GM search. Milanuk seconded the motion. Roll call vote: Yea: All present. Motion carried.

Attorney Jason Gray was present by teleconference. Strommen and Gulbranson remained for the Executive Session. Morgan left the meeting at 8:32 a.m. and returned to the meeting at 8:51 a.m., after completion of the FERC discussion.

A motion was made by Milanuk and seconded by Moffat to resume the meeting at 9:20 a.m. Roll call vote: Yea: All present. Motion carried.

FERC Settlement Offer on the Stated Rate Tariff Case

Zimmerman reported that we are still waiting to hear from Tri-State. No action was taken.

General Manager Search

Zimmerman reported that a posting for the General Manager replacement position will be made at NREA and NRECA.

Board Appointee Process for February 26, 2021, Regular Board Meeting

Strommen reported on the process for the two vacant board positions. Following her research, several recommendations were presented, and Statute 70-615 will be followed.

Recommendations from Strommen were:

The Chairman should appoint a three-person committee to conduct interviews. The interviews should be closed to the public and a list of standard questions that are asked of all interviewees should be formalized.

The Committee should prioritize three to four candidates for the Directors to vote on. The Directors may vote on whichever candidate they choose even if this is not a prioritized candidate.

The Board should nominate a candidate and then vote (one at a time). There should be a separate nomination for each candidate.

The Board cannot go into closed session to discuss the candidates. This action must take place in open session.

Following questions and discussion, a motion was made by Milanuk to form a Special Committee to review the applications and conduct the interviews. Blomenkamp seconded the motion. Roll call vote: Yea: All present. Motion carried.

President Zimmerman appointed Morgan as the Chairman of the Committee.

The Directors conducted ballot voting for two members for the Committee. Zimmerman and Milanuk were elected.

A Mission Statement was developed: To review and conduct interviews for the two open director positions.

A timeframe was established: February 17, 2021, is the cutoff date for applications to be submitted. Resumes will be submitted at the end of the work day on the 17th to the Committee members for review. The Committee will meet following the February 19, 2021, Special Board meeting to review and discuss the applications. Interviews will be scheduled for the week of February 22nd.

Other

Gulbranson reminded the directors that Form C-1, Financial Disclosure Statements for the State of Nebraska, are due March 1, 2021. Copies were given to the Directors.

The next Special Board meeting will be Friday, February 19, 2021, beginning at 8:30 a.m.
