Public Hearing & Comment Period

No one appeared before the Board.

Executive Session

An Executive Session was called at 8:32 a.m. by Moffat to discuss a FERC Settlement matter. Milanuk seconded the motion. Roll call vote: Yea: All present. Motion carried.

Attorney Jason Gray was present by teleconference. Strommen and Gulbranson remained for the Executive Session. Morgan left the meeting at 8:32 a.m. and returned to the meeting at 9:09 a.m., after completion of the FERC discussion.

A motion was made by Moffat and seconded by Blomenkamp to resume the meeting at 9:09 a.m. Roll call vote: Yea: All present. Motion carried.

General Manager Search

Zimmerman reported that several applications had been received.

Gulbranson and Weigle developed a Selection of General Manger Policy and presented a revised draft to the Board.

Strommen reported that letters have been sent to the applicants stating that Wheat Belt had received their applications and resumes. Strommen explained procedures for selection and questions and discussion followed.

Discussion was held concerning having a Wheat Belt employee on the interview committee. The directors agreed in order to keep the continuity with the employees.

Discussion was held concerning the final date for applications. At least thirty days was recommended and Gulbranson will have the posting edited to add the recommended date of March 15, 2021.

SPP Generation & Transmission Reliability and Rolling Blackouts

Gulbranson presented information on the rolling blackouts from the SPP Energy Emergency Alerts report and updated the Directors.

A timeline perspective was presented for the past week's interruptions.

Reilly also reported with Gulbranson. A key factor was reported: All forms of generation were impacted.

Morgan reported on Tri-State's capacity and pricing during the emergency outages.

Reports and discussion from the Board followed.

Gulbranson distributed the Safety Meeting sign-up sheets to the Directors.
