# AUTOPAY - THE EASY WAY



If you use a credit card, you are protected by the issuing bank. Even if you use a debit card, you are protected. No one can say they are 100 percent protected from any breach, but our on-line system is very secure.



### COLD WEATHER HEAT PUMP Efficiency to five degrees




Happy New Year! It has been a pleasure to serve your electrical needs over the past years, and I continue to look forward to finding better ways to make your lives better in 2019.

Wheat Belt PPD, and the electrical industry, continually work on research to improve on our delivery of electricity, and on better ways to use electricity, both in efficiency and comfort. We have several levels of research going at all times. I have been fortunate to serve on one of our national research councils and have an opportunity to guide the research, focusing on the rural needs. Our power supplier, Tri-State G&T, also conducts research on various ways to make electricity more efficient. Tri-State G&T partnered with the Electrical Power Research Institute (EPRI) to evaluate cold-climate air to air heat pumps. There are four test units that were installed in December as part of this research. Two of the units were installed in Wheat Belt's territory. These systems will maintain air to air efficiency down to approximately five degrees above zero, compared to traditional air to air heat pumps, which start losing efficiency below 32 degrees. The two-year test will prove these units



in our climate, will gather economic data for comparison to other heating sources, will monitor home comfort, various levels of temperature adjustments, and find optimum heating and cooling schedules to maximize efficiency. After the two-year EPRI test, Wheat Belt will continue to test the units for reliability, rate development, and home energy efficiency returns. We look forward to sharing the results of this research with the national industry, manufacturers, and with you, so that you can make the best choice when it comes to installing an HVAC system and other energy efficiency upgrades.

# WINTER SAFETY TIPS

It is heartbreaking to read about deaths or serious injuries caused by home fires, and I don't remember ever not hearing about a fire when winter hits. Whether it is from a faulty chimney, gas, propane or an electrical hazard, most home fires are totally preventable with diligence in checking equipment, cords and making sure you have fail-safe safety equipment installed.

Make sure your chimney is checked and clean, have routine maintenance performed on fossil fuel furnaces, and make sure your electrical appliances are in good repair and wiring is not frayed or undersized. Never hide or coil cords, and do not leave space heaters unattended that are not rated for constant use. Always buy UL listed appliances. Instruct your children never to leave anything lying in front of a heater

You should test your smoke and carbon monoxide detectors monthly. If you have children, make sure they know what to do in the case of fire. Everyone should know where the family will meet if different exits are to be used, and they should use the closest exit if it is not blocked by fire. If you have two stories, is there a ladder rope available for escape?



Don't assume it will not happen to you! Did you know, on average, seven people die every day from a home fire - most are children and elderly.


